## **Declaration and Client Consent Form**

I, \_\_\_\_\_, understand and declare, that I have consented to the following terms, as written by Dr. Karin Bender-Gonser, regarding future consultings/coachings:

1. The main communication tool for consultings/coachings is Zoom (Link will be send 10 Minutes prior to the appointment via E-Mail). In sessions I will state my key concerns and Dr. Bender-Gonser will ask questions to ensure a comprehensive understanding. Individual inspirations shall develop thereof aiming at solving my previously displayed issues.
2. The most crucial part of our consulting/coaching commences after our Zoom session. Contrary to traditional medical treatment and therapy, changes of my behavior patterns and healing are under my own responsibility with the aim on achieving long-term results.
3. I understand the following points as mandatory basis of the coaching's individual success:
  - I require sincere willingness to change.
  - My cooperation with Dr. Bender-Gonser will be without any reservation.
  - I possess the capability of maximal reflectance.
  - I feel capable to approach on what has been said on a rational level ,and subsequently put it into practice.
  - I am aware of being an autonomous individual and that change underlies my own responsibility without any dependence of others.
  - During the consulting/coaching, my physical and mental receptiveness for the process will not be influenced by any consumption of narcotics, intoxicants and psychotropic drugs.

4. Furthermore, I recognize the possible results of consultings/coachings,:

- If I meet the previously mentioned conditions, consultings/coachings can be a life changing tool.
- New insights obtained during consulting/coaching sessions may impact my mental state, my behavior and physical appearance.
- Consultings/coachings do not primarily aim on instant healing during sessions but rather serve as guidance to self-awareness. It will help me realize my behavioral patterns in order to instigate change.
